Trade Like a Champion Competition

Terms & Conditions

1. Subject to the Trade Like a Champion Competition Terms and Conditions (the “Competition Terms”) and easyMarkets (the “Organiser”) business terms and policies set forth on the easyMarkets Legal Page, clients that meet the criteria of the Competition Terms set forth hereinafter will be eligible for the Trade Like a Champion Competition (the “Competition”) as defined below.

2. The Competition shall commence on 1st of October 2020 and shall continue until 30th of November 2020 (the “**Competition Period**”).

3. Conditions of Eligibility:

Subject to, and without prejudice to, all other Business Terms and Policies, the Competition is available to easyMarkets’ Clients (“Participants”) who have satisfied the Eligibility Criteria (“Eligible Participants”) as set out in the Sections following hereinafter.

The Eligibility Criteria for the Competition are as follows:

a. This Competition shall apply to all new and existing clients/traders of easyMarkets who open a live trading account both on easyMarkets Web Platform and MT4 Platform trading on any available financial instrument.

b. Only persons who can form legally binding contracts under the laws applicable in their country of residence may participate in the “Competition”; without limiting the foregoing, participation in the “Competition ” is not allowed for persons under the age of 18.

c. Eligible Participants must provide easyMarkets with true, accurate, current and complete information, including but not limited to their full name, identical to that specified in their ID documentation, as well as an active contact e-mail and phone number, and must upload all necessary, clear and legal documents in the member’s area. Eligible Participants must agree not to impersonate any person or entity, misrepresent any affiliation with another person, entity or association, use false headers or otherwise conceal their identity for any purpose. easyMarkets will treat with care all such information that is entrusted to it, in accordance with the disclosures provided during the registration process and in easyMarkets’ Privacy Policy.

4. Qualification Criteria

The Competition winners (the “Winners”) will be determined as per the below factors:

a. The Eligible Participant who has the highest number of profitable round trip trades compared to their total number of round trip trades for the period under consideration, i.e. 1st of October 2020 and shall continue until 30th of November 2020 qualifies to take part in the Competition.

b. The Eligible Participants in order to qualify must complete a minimum number of “30 round trip trades”.

5. Competition Prizes

The Competition Prizes will consist of both “Cash Prize” and “Real Madrid Merchandise” as follows:

a. First place – One (1) Winner

The Eligible Participant with the highest percentage in profitable round trip trades who has met the abovementioned qualification criteria will win Ten Thousand US Dollars (10000 USD) and an official customized Real Madrid jersey.

b. Second Place - One (1) Winner

The Eligible Participant with the second highest percentage in profitable round trip trades who has met the abovementioned qualification criteria will win Three Thousand US Dollars (3000 USD) and a Real Madrid polo shirt.

The Eligible Participants with the third highest percentage in profitable round trip trades who have met the abovementioned qualification criteria will win One Thousand US Dollars (1000 USD) and one Real Madrid Historic Football.

6. In the event of a tie between Eligible Participant, the Eligible Participant who has completed the most trades qualifies.

7. If again, there is a tie then the Eligible Participant who has been participating in the competition the longest gets to qualify.

8. In the event that, the traders have not met the abovementioned requirements/criteria, easyMarkets reserves the right to withdraw the prizes.

9. By entering the competition, all participants will be deemed to have accepted and be bound by these terms and conditions, which shall be interpreted by easyMarkets at its sole discretion.
